I am proud to inform you all that Namibia is preparing itself to be the world-preferred destination for the offshoring of ICT services. This is an exciting development, and we welcome everyone to join us on this journey. The opportunities are immense, and together we can make it happen.

Namibia is currently drafting and reviewing the following legislation and policies to accelerate ICT development, access and innovation

- o Cybercrime Bill
- o Data Protection Bill

- Amendment of the Communications Act
- o Review of ICT Policies and consolidation into a National ICT Policy
- National Digital Strategy Concept note

This presents the Ministry of Information and Communication Technology with an opportunity to develop laws and policies that will make Namibia an attractive destination for doing business in ICT. The world should feel safe to have its data, stored and processed in Namibia. The world should be confident of our ability to do business in the digital space. Namibia's cyberspace should be the freest and safest world over. The task is humongous but it can be achieved if we all pull our weight.

We cannot ignore the gaps that still exist, hindering digital transformation in Namibia. These gaps range from infrastructure challenges to affordability. The activation of the Universal Service Fund will help Namibia overcome some of these challenges.

Finally, distinguished guests, digital transformation is a powerful tool that can help us address the unemployment crisis in Namibia and make Namibia a global player in the ICT space. We must work together to develop alternative avenues to finance digital start-ups and ICT entrepreneurship, reduce the gaps hindering digital transformation, and increase digital literacy. Let us embrace these changes and work towards a brighter, more prosperous future for Namibia.
